We are pleased to welcome you to Sandalwood Enclave (the Enclave), proudly managed by Lime Property Management. The Enclave forms part of the broader Sandown Property Owners Association (SPOA), which oversees and supports the greater Sandown precinct.

FINANCIAL INFORMATION & LEVY STRUCTURE

The Enclave's financial year runs from 1 March to the end of February each year. Levies are reviewed annually and may be adjusted as of 1 March, based on the guidelines outlined in the SPOA constitution. Levy amounts are determined by the participation quota (PQ) of the size of your erf.

The total levy amount comprises of three components:

1. The Enclave levy, which supports the day-to-day operations and maintenance of the Sandalwood Enclave,
2. The Sandown POA levy, which contributes to the upkeep and security of the broader Sandown area, and
3. The Community Schemes Ombud Service (CSOS) levy, which applies only if your total monthly levy exceeds R500. In such cases, a 2% CSOS levy is charged on your monthly levy, capped at R40.

Please refer to the Levy Roll for individual levy amounts.
